Payment Information

- All applicable fees are due on July 15, 2026 except Volunteer Hours. Fees are non-refundable.
- Tuition Payment Options:

Monthly tuition payments are due each month on the 15th; starting on August 15, 2026 and ending on May 15, 2027 (10 months).

Bi-Monthly tuition payments are due every other month on the 15th; starting on August 15, 2026 and ending on April 15, 2027 (5 months).

Pay in Full is due on July 15, 2026.

- Liberty will issue a \$20.00 / monthly service charge to an account which is not meeting its financial obligation. There will be a \$20.00 service charge on any check returned for lack of sufficient funds.
- Tuition Refund: If a student is enrolled for one day in a semester, the family will be charged tuition for the full semester.
- If a family withdraws from Liberty after being fully accepted for the 26-27 school year, there will be a \$200 exit fee assessed per child. A current student may withdraw from February 1, 2026 through April 16, 2026 for the 26-27 school year with no withdrawal penalty; otherwise, there is a \$200 exit fee per child.
- Payments can be made via cash, check or PayPal (2.1% processing fee...this fee can vary a little)
